_____ I understand the tuition payment is due on the 1st of each month, and is considered late if paid after the 5th of the month.

_____ I understand any tuition payments received after the 5th of the month will incur a late fee of \$50 per child. If the 5th of
Initial the month falls on a weekend or holiday, the tuition fee is due **before** that weekend or holiday - no exceptions.

_____ I understand personal checks cannot be used to pay for tuition. Automated Clearing House or ACH is the preferred method
Initial for MHMS for all tuition payments unless the tuition payment is made in cash, money order, cashier's check, or has already been paid in full. ACH is generally scheduled to be processed on the 1st of each month.

_____ I understand that in the event that the bank account tied to the tuition payment lacks the funds to meet the tuition
Initial payment, an insufficient funds' fee will be charged by the bank. If the tuition payment is late, there will also be a \$50 late payment fee. A \$35 bank fee will be charged for each payment returned by the bank for any reason. This fee must be paid by the parent/guardian immediately upon notice from the MHMS Administration. If a notice is given and not paid by the 5th of the month, a late fee of \$50 per child will be applied.

_____ I understand MHMS does not send monthly invoices. It is the parent/guardian's responsibility to stay current with the
Initial tuition payments as stated in the tuition fee schedule.

_____ I understand if there is a discrepancy in tuition payments, the parent/guardian is responsible for providing the proof of
Initial payment.

_____ I understand that my ACH authorization will remain in effect until I cancel it in writing, and I agree to notify Mission Hills
Initial Middle School in writing of any changes in my account information or termination of this authorization **at least 15 days prior** to the next billing date **and** provide details of the new payment method (ex. new filled out ACH form).

_____ I understand annual tuition for the school year will not be prorated or credited, in whole or in part, for any reason.

_____ I understand a 30-day written notice is required for early withdrawal. In case of a mid-month withdrawal date, tuition is not
Initial refunded or prorated for the remainder of the month. Failure to provide a 30-day notice will result in a charge for the next monthly tuition fee.

_____ I understand MHMS does not charge for before school or after school care. The extended care provided is free of charge
Initial to all our students whether they choose to participate in it or not. The payments I make are for tuition only. **Dependent care accounts (FSA) will not be utilized.**
